## **MEA MEMBER DISCOUNT PROGRAM**

### **Guidelines for Approval of Member Discount Programs**

- ◆ Merchants must complete the official Application for Retail Listing in the MEA Member Discount Program.
- ◆ Merchants selling products or services that compete with MEA-sponsored vendors are not eligible for this program. This includes auto and homeowners insurance, disability and long-term care insurance, certain financial services, travel agencies and car rental discounts.
- ◆ The discount must be available to all MEA members.
- ◆ Members must present a current MEA/NEA membership card to receive the discount.
- ◆ The discount must be in effect for at least one year.
- ◆ Merchants who discontinue the discount during the effective period will be prohibited from participating in the program in the future.
- ◆ Merchants listed in the MEA Member Discount Program must not state or imply an MEA endorsement of their product or service.
- ◆ Merchants must provide a phone number for member inquiries about the program.
- ◆ Merchants must designate a sales representative to act as the official contact person with the MEA Member Benefits representative.
